E-Community Program Description & Application

The Bird City E-Community Program, created through a Kansas Center for Entrepreneurship tax credit program, is a program to encourage entrepreneurial activity in the Bird City community.

Qualifying entrepreneurial projects including start-up businesses, existing business purchase or existing business expansion, may apply for funding up to \$45,000. Two types of funding will be offered from the fund: grants and low interest loans. Grants shall be reserved for those projects determined to have the greatest weighted cumulative score (see scoring criteria on page 7) and will primarily be reserved for projects that demonstrate a high likelihood of success. Loans with a very low interest rate are the more common funding mechanism.

This application should be completed in full. The following list of items should be considered for inclusion with the application; noting that additional consideration will be given to applicants that provide the maximum information.

Items to include with your application:

- A complete business plan, including sales and employment projections;
- Financial reports and/or a bank financial application;
- Resumes and references for the principals of the business.

NOTE: All recipients of the Bird City E-Community Program **MUST** attend a Business Start-up Session through the Kansas Small Business Development Center.

NOTE: All recipients of the Bird City E-Community Program **MUST** live in Bird City and the business **MUST** be based in Bird City. If the main business operation should ever move out of Bird City, all monies must be paid back immediately.

Completed applications will be reviewed and scored by the Financial Advisory Board, and a formal interview will be scheduled with the applicant. In the formal interview, advisory board members will ask specific questions that pertain to the following criteria:

- Explanation of the applicant's need for funding and how the funds will be used;
- Projected sales or sales growth, jobs retained or added, increased tax revenue, and/or community benefits;
- Funds provided by the entrepreneur (down payment) and any third party funding (banks, etc.);
- Local support for the project through (i.e. letters of support)

It should be noted that this program is a fairly new program, and the application process will be a work in progress, and should be expected to be fluid in nature.

- Bird City E-Community Fund applicants are required to submit an official application. In addition, applicants must submit a complete business plan with three year financial and job projections.  - g. Description of how the funds will be utilized to add resources, enable the business to add jobs, increase tax revenue and/or improve the quality of life to Bird City.

Based on applicant's answers to each criteria question, advisory board members, will submit an overall score on a 1 to 10 scale with 10 being the highest and 1 the lowest based on the applications ability to successfully meet criteria. The average total score will be calculated then the amount and terms of the Bird City E-Community Fund Loan or Grant will be awarded. Average scores and comments will be documented for each criteria question.

- The Bird City Century II Development Foundation Executive Director will provide administrative support to the Bird City E-Community Fund Financial Advisory Board and provide Network Kansas a list of approved businesses and loan or grant amounts, the application and scoring system used for approval and initial information about the business. These duties will be part of the day to day responsibilities of the Bird City Century II Development Foundation Office. All businesses that receive loans or grants will be input into the Network Kansas Business Tracker software database for semi-annual follow-up by a Network Kansas Counselor.
- The Bird City E-Community Fund Advisory Board meets as needed.
